290 North Street, Daniel Toscano, for North Street

**Realty Trust,** has applied to the Board of Appeal to change the legal occupancy of the building from a bed and breakfast and one residential unit to a four-family residential dwelling. No exterior work is to be performed.

**2 Snelling Place, Daniel Toscano, for Mirchandori Bharat Chellaram,** has applied to the Board of Appeal to change the legal occupancy of the building from a three-family residential dwelling to a two-family residential dwelling. The plans call for extending the living space of the first floor unit into the basement, and erecting a one-story addition to the existing property. The building will not exceed 55-feet in height (increase from 36 to 45 feet) and will be fully sprinklered.
