<u>10-12 Fleet Street, Mai Phung/Porzio Studio of Architecture</u>, has applied to the Board of Appeal to change the allowed use and occupancy of an existing retail space into a nail salon. The space is located on Fleet Street near the corner of Hanover Street, and is currently vacant.

Chellaram, has applied to the Board of Appeal to change the legal occupancy of the building from a three-family residential dwelling to a two-family residential dwelling. The plans call for extending the living space of the first floor unit into the basement, and erecting a one-story addition to the existing property. The building will not exceed 55-feet in height (increase from 36 to 45 feet) and will be fully sprinklered.
