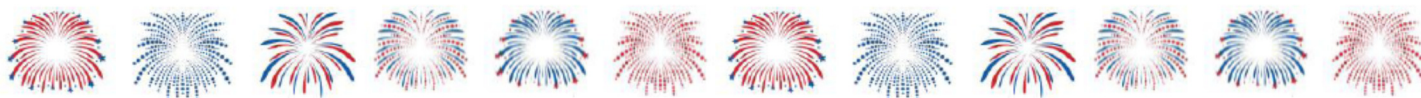

Jason will provide updates on the latest efforts regarding the North End Nursing Home, including how NEWRA members can help if interested.

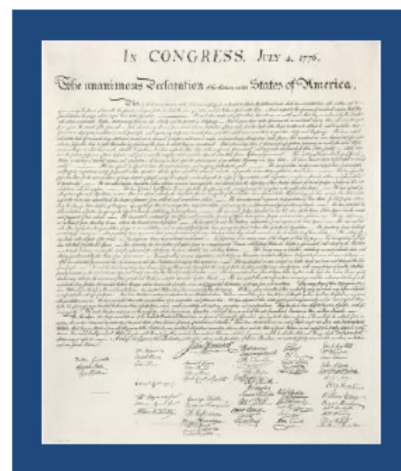
